Terms of the product	The Fund has no end date. The Fund Manager may terminate the Fund according to the terms of the Fund.

The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.
